## **TRADE & CREDIT CONDITIONS**

Globe-Tech Australia Pty Ltd trading as "THERMABAG" shall only supply goods to you on the following terms & conditions unless we agree, in writing, to vary these terms & conditions.

### **PAYMENT OF ACCOUNT**

- 1) All invoices are due for payment in full on or by the last banking day of the month following the date of the invoice.
- 2) No discounts are given or should be deducted at time of payment.
- 3) An interest charge of 1.5% per month will apply, on any amount which falls due for payment but remains unpaid, and will continue until paid.
- 4) Accounts may be paid electronically to our bank account as follows;

### **FEES & CHARGES**

- 1) All returned or dishonoured cheques by the bank will incur a fee of \$30.
- 2) Request of a copy of invoice 3 months old will incur a service fee of \$10.
- 3) Failure to advise proper electronic details of payment to our account resulting in a bank search will incur a service fee of \$15.
- 4) Stands are given free on a consignment basis but a fee of \$100 will apply if not returned when trading is stopped for whatever reason.
- 5) You will become liable and be charged for all expenses incurred by us for the recovery or attempted recovery of the overdue amounts from you.

### **ORDERS & DELIVERIES**

- 1) Orders may be placed by phone, fax or email.
- 2) Orders for a quantity in excess of 5 cartons will be delivered FIS.
- 3) Orders for a quantity of less than 5 cartons will incur a freight charge subject to destination.
- 4) All orders will be forwarded by our designated couriers. 5) No returns will be accepted unless notified in advance.

### **RESERVATION OF TITLE**

- 1) You acknowledge that the ownership of the goods delivered by us to you is only transferred to you when you have paid all sums owing to us on any account whatsoever and until such time, we have the right to call for or recover the goods at our option.
- 2) Subject to (1) above our employees or agents may enter the premises and you are obliged to deliver up the goods if so directed by us.
